GRIGGS FARM WAS DEVELOPED THROUGH THE FEDERAL LOW INCOME HOUSING TAX CREDIT PROGRAM; ALL TAX CREDITS WERE REDEEMED IN 2005. THERE ARE NO CURRENT GOVERNMENT SUBSIDIES AND GRIGGS FARM INC.'S OPERATIONS ARE FINANCED SOLELY FROM THE RENTAL INCOME DERIVED FROM ITS 70 UNITS.
